I understand there shall be no initial initiation fee due upon submission of my Application for Membership, in conjunction with my Preview membership term. By electing to join, in a provisional preview relationship, I agree to the following terms and conditions as they relate to joining Oakwood Country Club.

1. **Commitment to preview relationship with Oakwood Country Club for a preview term of membership through February 28, 2019.** I hereby obligate myself for the payment of all applicable monthly dues, fees and all charges incurred during my preview membership term, subject to the terms associated with the “Discover Oakwood Country Club” Preview Membership Initiative.
2. **Termination of privileges or membership purchase at conclusion of the preview membership term.** After my required preview term has concluded, all of my privileges hereunder shall terminate unless I elect to do one of the following:

a. **On or before July 31, 2018**, pay the “Discover Oakwood Country Club” Preview Membership Initiative preferred initiation fee for the applicable membership category shown below:

b. **After July 31, 2018**, and on or before the conclusion of the preview term (February 28, 2019), pay the initiation fee in full for the applicable category of membership as shown below.

3. **Privileges and limitations during preview period.** During my preview relationship, in the event I do not become a member of the Club under 2.a. above, I shall be entitled to the use of the Club facilities and involvement in all Club activities (excluding major Club tournaments/events as determined by Oakwood Country Club) and usage privileges in the category of membership in which I am approved, provided I am current with respect to all financial obligations. Additionally, I understand my preview relationship is not transferable or refundable.
  
4. **Oakwood Country Club By-Laws and Rules and Regulations.** I agree to be bound by the By-Laws and Rules and Regulations as established and may be amended by Oakwood Country Club, from time to time.
  
5. **Revocable Membership.** In the event I do not become a member of the Club under 2.a. above or thereafter, the Club has the absolute right and discretion to revoke my membership at any time before the preview membership terminates (February 28, 2019). If the Club exercises its right, I remain obligated and promise to pay monthly dues, fees and all charges incurred through the date on which the Club exercises its right to revoke my membership.
  
6. **Final interpretation.** The Club reserves the right to make final decisions pertaining to all matters regarding the “**Discover Oakwood Country Club**” Preview Membership Initiative.
  
7. **Credit Card Authorization for past due accounts.** I agree to maintain a current credit card account on file with the Club at all times. Should my account become delinquent, I agree the Club shall have the right to bill such past-due amount and all future charges to my credit card.
